## HIGHLIGHTS

Dr. Susan McCauley has taken the helm at the Department of Education after the resignation of Commissioner Mike Hanley. She starts March 1<sup>st</sup> as the interim commissioner.

Juneau has lost more state jobs over the past two years than any other place in Alaska, said OMB director Pat Pitney. As presented in Senate Finance, Juneau lost 198 state jobs. Anchorage, with twice the number of state employees, only lost 193 positions.

The Alaska Code of Military Justice bill (**HB 126**) passed the House. The bill would modernize the outdated Code and provide a framework for the proper tools and procedures to help the Guard enforce order and hold guardsmembers accountable.

**HB 11** is awaiting transmittal to the governor following passage this week. It removes records from Court View (the state's online court records database). They would be scrubbed after 60 days for people whose cases are dropped and dismissed, or if they are found innocent at trial. The records will still be kept in hard copy.

Pets are rejoicing across Alaska as **HB 147** received a hearing in Judiciary and is scheduled again this coming week. This bill spells out protections for animals in domestic violence situations and has broad bipartisan support.

The state is launching a new effort to investigate former VECO chief Bill Allen for sex crimes, according to Alaska Attorney General Craig Richards and U.S. Senator Dan Sullivan.

Members of the Alaska Correctional Officers Association held a press conference to say they're unhappy with the governor's choice for Corrections' commissioner.

The Alaska House Speaker has introduced legislation to block our attorney general from serving on state boards and commissions.

"Misleading" is how the Legislative Affairs Agency put it. They were responding to a statement by the landlords of the Legislature's Anchorage office building that purchasing the building could save the state millions of dollars.

## **BUDGET ISSUES**

A new poll by Alaska Dispatch News shows that most people support Governor Walker's plan to close the state's budget gap, even though it would reduce Alaskans' PFD checks. On the other hand, many at a recent legislative hearing said leave the dividend alone and keep cutting.

Without backing a specific proposal, economist Gunnar Knapp said Alaska lawmakers will have to consider five different factors to fix the budget:

Evaluate what we spend on government, what we spend on PFD's, what new tax revenue could be added, how to inflation-proof the Permanent Fund (PF), and what other growth the state might have in the PF earnings reserve and the CBR Fund.

### **CONSTITUTIONAL ISSUES**

DNR Commissioner Mark Meyers has hinted at delays in developing the most challenging agreements between the gas producers. This is threatening the timeline for an anticipated special session to ratify key elements of the AKLNG gasline project.

A Constitutional amendment on fiscal terms could face voters in the November general election.

A state Senate committee heard testimony this past week to amend the U.S. Constitution and establish a mechanism for states to overturn certain federal decisions.

### **EDUCATION ISSUES**

Alaska Senator Click Bishop and Rep. Geran Tarr are sponsoring a "Lunch & Learn" this coming Thursday. Begins at Noon in Room 106 of the Capitol. You will learn how the early care and learning sector provides thousands of jobs for Alaskans and pumps \$512 million into our economy.

The latest data collected by the federal government show that Alaska spends more on elementary and secondary education than any other state. Anchorage was ranked fourth per-pupil. Only Philadelphia, Boston, and New York City spent more.

A University of Alaska program – ANSEP – educates Alaska Native students in science, technology, engineering, and math. It's proposing to take over the Mt. Edgecumbe High School.

### **HEALTH & SOCIAL SERVICES ISSUES**

**SB 53** – The Advanced Practice Registered Nurses legislation has a hearing in House Finance on Wednesday. This is the last committee before going to the Floor for a vote!

A state court judge heard arguments in a lawsuit over Governor Walker's authority to expand Medicaid without legislative approval. Superior Court Judge Frank Pfiffner said it could be the end of March before he renders a decision. Appeals may be next.

The Senate's MEDICAID REFORM Finance Subcommittee was very busy with hearings on SB 74 and **SB 78**. Another round of multiple hearings will be conducted in the week ahead.

**HB 227** was heard in the House HSS Committee. This bill contains all of the reforms and amendments in the HSS draft of the governor's **HB 148**. Since Medicaid expansion was accepted, the expansion clauses have been removed from both bills.

### **PUBLIC SAFETY ISSUES**

House Judiciary is taking testimony on Monday for **SB 23**. This is the last committee of referral. As amended, it establishes standards for dispensing by a pharmacist and includes the completion of an opioid overdose training program.

It goes on further to define "program" to include the use of electronic, video, or automated education. The House HSS CS also added the word "nurse" to the description of health care provider.

## **NATURAL RESOURCES**

Governor Bill Walker announced his most recent appointments to the Board of Fish. Alan Cain of Anchorage, Israel Payton of Wasilla, and Robert Ruffner of Soldotna will join the Alaska Board of Fisheries, which sets regulations and policy related to the state's fishery resources. This will be Mr. Ruffner's second chance at confirmation.

The point man in Washington DC for Arctic issues was recently in Alaska. Mark Brzezinski is the executive director of the Arctic Executive Steering Committee that oversees the many federal agencies with a hand in the U.S. Arctic.

Alaska LNG has purchased close to 600 acres at a site in Nikiski that could eventually house the project's gas liquefaction plant.
